

CHI Health at Home Application Instructions

To support you through each step of our process, we have outlined some tips to help make your application experience easy.

System Requirements

Our application system is best suited with the following browsers:

- Internet Explorer release 8 or higher
- Firefox 3.5.1 or higher
- Safari 3.1
 - If your current operating system is not using one of these browsers, please try applying on another computer which meets these qualifications.

Pop-Up Blocker – Be sure to turn off your pop-up blocker.

“Cleaning” Your computer - If you have the proper operating system and you experience problems loading the application page, we suggest you try one of the following:

- Clearing your browser’s temporary files, or cache
- Complete a security check for computer viruses
- Look for a small gray icon representing a torn sheet of paper on the top tool bar just to the right of the field used to enter a URL. Click the gray, broken paper icon and it will turn blue. Make sure the icon stays blue after you move your mouse away. When the icon is blue, compatibility mode is turned on. A gray icon indicates compatibility mode is turned off.
- Go to the Tools menu (you may need to press [Alt] to see the Menu bar), select Compatibility View Settings, and click [Add] to view the specific page you are on in Compatibility View (or select Display all websites in Compatibility View).

Smart Devices - If you are trying to access the application system on your smart device, we cannot guarantee your results. Smart devices include, but are not limited to, tablets, smart phones, and smart televisions.

Internet Connections - Internet connections will vary based on the provider and technology used for each smart device. Always verify the problem is not with your service provider and has available service and, if using a Wi-Fi connection, verify a user id and password is not required.

Step 1: Registration

Applicants must register before completing an application with CHI Health at Home. As part of this process, applicants will be asked to create a user name and password. During the registration process, it is important for you to add your current email address to your recruiting profile.


User Name and Password

If you are registering with CHI Health at Home for the first time, please maintain a record of your User Name and Password. This will help you easily access our system at your convenience.

If you forget your log-in credentials, you can recover your User Name and Password using a valid email address.

Step 2: Job Search

Once logged in, applicants can enter various keywords to search for certain positions. If you are having difficulties searching for a position, change the “Posted” drop down box from “Last Month” to “Anytime”.

Step 3: Application Process

Applicants can include a resume when completing an application. When uploading a resume, please attach only a Microsoft Word or Adobe PDF document.

Complete all portions of the online application, even if information is duplicated from your resume. We require your last five employers on the application. Applicants will be asked to complete an Application Questionnaire towards the end of the application. All questions must be answered to have a complete application. Your application will time out after 60 minutes idle. The system will not auto-save at this time. In order to submit your application, you must click “Submit”.
